BOARD MEETING  
October 10, 2008

The meeting was called to order at 6:25 PM by President Lou Joseph.

PRESIDENT'S REMARKS

Lou Joseph welcomed the members and held a moment of silence in memory of Roni Gitchel Atkins.

MINUTES OF PREVIOUS MEETING

The minutes from the meeting of August 1 were previously e-mailed to the members. The minutes were approved after the correction of a spelling error.

CORRESPONDENCE

Steve Nolan presented a proposed revision of the bylaws to Mary and Lou. Mary has distributed these to the board members. The ACBL presented a document containing Unit Duties and Responsibilities which Mary distributed to the board members.

TREASURER'S REPORT

Ivan distributed the Treasurer's report. The Ronald McDonald House will receive a donation of \$1026 from the Pro-Am Game. The Instant Matchpoint Game was a bridge and financial success.

The Expo Mart has closed; the Radisson is reopening as a Doubletree, and a Convention Center will be developed in the old Wickes Building in Monroeville. The latter is the planned site of the Regional. If this site isn't ready for August, the Radisson/Doubletree will accommodate us in Ballrooms for 2008.

## OLD BUSINESS

**Spring Sectional Financial Report**—Ivan presented the report for Arlene.

**Summer Sectional Financial Report**—Sharon Rohr sent the report to Ivan, who presented it.

**Pro-Am Game**—Lou reported that the game was a great success thanks to Sharon Rohr, Gail Hastings and Sue Mc Quillan. A special thanks from the board goes to Alex Bealles who donated his directors fees, and provided preduplicated boards with hand records.
